O R D E R

On December 15, 1988, South Central Bell Telephone Company ("South Central Bell") filed an application to restructure and reprice its private line services tariff and adjust rates in its access services tariff, effective January 16, 1989. On January 3, 1989, MCI Telecommunications Corporation ("MCI") filed a motion to suspend the tariff filing and hold a public hearing.

After review of the tariff filing and being advised, the Commission is of the opinion and finds that additional investigation and public hearing will be necessary to determine its reasonableness. Also, such investigation and public hearing cannot be completed prior to the proposed effective date. Therefore, MCI's motion should be granted and the tariff filing should be suspended.

IT IS THEREFORE ORDERED that:

1. MCI's motion to suspend South Central Bell's tariff filing and hold a public hearing be and it hereby is granted.
2. South Central Bell's tariff filing to restructure and reprice its private line services tariff and adjust rates in its access services tariff be and it hereby is suspended for a period

of 5 months from the proposed effective date, through June 16, 1989. The tariff pages hereby suspended are listed in Appendix A.

3. Nothing in this Order shall prevent the Commission from entering a final decision in this case prior to the termination of the suspension period.
