**O R D E R**

On April 7, 1989, West Daviess County Water District ("West Daviess") filed its application for Commission approval of a proposed increase in its rates for water service. The proposed rates for water service would generate additional annual revenues of \$35,402, an increase of 6.42 percent above test-year revenues.

In May 1989, Commission Staff conducted a field review of 1988 test-period financial records. Based upon this review, Commission Staff issued its report on July 18, 1989, recommending the proposed rates be accepted.

By letter dated July 19, 1989 West Daviess was advised to file comments on the Staff Report or request a hearing no later than August 3, 1989 or the case would stand submitted to the Commission for decision. No comments on the Staff Report or requests for a hearing have been received.

The Commission, after considering the evidence of record and being sufficiently advised, finds:

1. The recommendations and findings contained in the Staff Report regarding the increase in basic rates are supported by the

evidence of record, are reasonable, and are hereby adopted as the findings of the Commission in this proceeding and are incorporated by reference as if fully set out herein.

2. The rates in Appendix A, attached hereto and incorporated herein, are the fair, just, and reasonable rates for West Daviess and will produce gross annual revenues of \$598,864. These rates will allow West Daviess sufficient revenues to meet its operating expenses, service its debt, and provide for future equity growth.

IT IS THEREFORE ORDERED that:


1. The rates proposed by West Daviess and contained in Appendix A are approved for service rendered by West Daviess on and after the date of this Order.

2. Within 30 days of the date of this Order, West Daviess shall file with the Commission its revised tariff setting out the rates approved herein.
