INTERIM ORDER

This matter arising upon motion of AT&T filed December 7, 1989 to withdraw a previously filed motion requesting authority to implement partial rate reductions in five of its business services. AT&T states in its most recently filed motion that it withdraws its earlier motion in its entirety with the exception of the SDN reduction requested.

AT&T represents to this Commission that it is seeking this rate reduction regardless of the outcome of the proposed Private Line rate adjustment in this proceeding. Additionally, AT&T affirms that the reduced SDN rates being proposed are priced above the incremental cost of providing this service.

This Commission being otherwise sufficiently advised, HEREBY ORDERS that:

1. AT&T's motion requesting authority to implement its SDN rate reduction is hereby granted. The rates in Appendix A, attached hereto and incorporated herein, are approved for service rendered by AT&T on or after December 15, 1989.

- 2. Within 30 days of the date of this Order, AT&T shall file with the Commission its revised tariff setting out the rates approved herein.
- 3. The approval of this rate reduction is interim in nature and shall not affect the Commission's final decision in this matter. If the Commission orders rates higher than those approved herein, any shortfall shall be absorbed by the shareholders rather than ratepayers.
