O R D E R

On July 26, 1989, Dexter-Almo Heights Water District ("District") filed its revised tariff with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being sufficiently advised, is of the opinion and finds that:

1. The District's supplier, Murray Water and Wastewater System ("Murray"), increased its rate for water sold to the District from \$.69 to \$.85 per 1,000 gallons, effective December 6, 1988.

2. The District increased the rates to its customers effective July 1, 1989.

3. During the 12 months ending May 31, 1989, the District purchased 25,814,000 gallons of water and sold 20,417,700 gallons.

4. The calculations made by the District are correct and show an increase in purchased water costs of \$4,130, resulting in a purchased water adjustment of \$.20 per 1,000 gallons.

5. The purchased water adjustment of \$.20 per 1,000 gallons of water and the rates in Appendix A are fair, just, and reasonable and should be approved.

6. The tariff proposed by the District is correct and should be approved as filed.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of \$.20 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are approved for services rendered on and after July 1, 1989.


2. The proposed tariff is approved as filed.
