O R D E R

On July 26, 1989, Grayson County Water District ("Grayson County") filed an application requesting to establish a meter connection fee for a 5/8 inch meter, a 1 inch meter, a 1 1/2 inch meter, a 2 inch meter, a 3 inch meter, a 4 inch meter, and a 6 inch meter. Grayson County also proposed to establish a \$25 inspection fee for inspecting the service line. On August 14, 1989, the Commission issued a letter requesting additional information concerning certain filing deficiencies be filed within 15 days. On August 17, 1989, Grayson County filed the requested information.

In its application, Grayson County provided a copy of its public notice of the proposed charges. Also included in the application was a copy of the Affidavit of Publication verifying that the notice was published on June 12, June 29, and July 6, 1989.

Grayson County has filed schedules with the Commission which itemize the expenses involved in providing a metered service connection and a service line inspection charge. A review of these schedules indicates that the proposed charges are equal to

the expense of each charge and that the individual expenses are reasonable.

The Commission, having considered the evidence and being advised, IT IS HEREBY ORDERED that:


1. Grayson County shall be and hereby is permitted to establish the meter connection fees for 5/8 inch meters, 1 inch meters, 1 1/2 inch meters, 2 inch meters, 3 inch meters, 4 inch meters, and 6 inch meters set out in Appendix A, attached hereto and incorporated herein.

2. Grayson County shall be and hereby is permitted to establish a service line inspection charge as set out in Appendix A hereto.

3. Within 30 days from the date of this Order, Grayson County shall file its revised tariff sheets setting out the charges approved herein.
