#### ORDER

On August 24, 1989, Salt River Water District ("Salt River") filed an application requesting to increase its tap-on fee for a  $5/8 \times 3/4$  inch meter and establish charges for a service reconnection during and after business hours, a meter reading recheck, a requested meter test, a returned check, and a meter reset. On September 11, 1989, the Commission issued a letter requesting additional information concerning certain filing deficiencies be filed within 15 days. On September 26, 1989, Salt River filed the requested information and indicated that it would begin running the notice in the Pioneer News in October.

On November 1, 1989, Salt River filed a copy of the affidavit verifying that the notice was published on October 4, October 11, and October 18, 1989.

Salt River has filed schedules with the Commission which itemize the expenses involved in providing a meter tap-on fee, a service connection charge during and after business hours, a meter reading recheck charge, a requested meter test charge, a returned check charge, and a meter reset charge. A review of these schedules indicates that the proposed charges are equal to the expense of each charge and that the individual expenses are reasonable.

The Commission having considered the evidence and being sufficiently advised, HEREBY ORDERS that:

1. Salt River shall be and hereby is permitted to establish a meter tap-on fee for a  $5/8 \times 3/4$  inch meter as set out in Appendix A, attached hereto and incorporated herein.

2. Salt River shall be and hereby is permitted to establish a service connection charge during and after business hours, a meter reading recheck charge, a requested meter test charge, a returned check charge, and a meter reset charge as set out in Appendix A hereto.

3. Within 30 days from the date of this Order, Salt River shall file its revised tariff sheets setting out the charges approved herein.
