## ORDER

Before the Commission is the application of Nolin Rural Electric Cooperative Corporation ("Nolin") for approval of a revision to its electric power tariff. The application was filed as a result of a proposed decrease in power costs from Nolin's wholesale power supplier, East Kentucky Power Cooperative, Inc. ("EKPC"). The rates proposed by Nolin are intended to flow-through to its customers the scheduled power cost reduction from EKPC. Nolin's revised tariff was to have become effective December 1, 1989 but was suspended for a period of 5 months.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that:

1. EKPC, Nolin's wholesale power supplier, has been authorized to reduce its rates for wholesale electric power.

Case No. 89-311, The Notice of East Kentucky Power Cooperative, Inc. of a Revision to Its Wholesale Power Tariff.

- 2. Nolin should be authorized to reduce its rates in order to effect a flow-through of the wholesale power cost reduction from EKPC.
- 3. The rates and charges in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and will accomplish a flow-through of the power cost reduction from EKPC.

IT IS THEREFORE ORDERED that:

- 1. The rates and charges in Appendix A are approved for service rendered by Nolin on and after January 1, 1990.
- 2. Within 30 days from the date of this Order, Nolin shall file with the Commission its revised tariff sheets setting out the rates approved herein.
