ORDER

On November 21, 1989, International Telecharge, Inc. ("ITI") filed a proposed tariff with the Public Service Commission ("Commission") which offered a new service entitled Bulk Transmission Service. By Order dated December 15, 1989, the tariff was suspended for 5 months through May 21, 1990. Motions filed by South Central Bell Telephone Company ("SCB") for leave to intervene and to serve data requests on ITI were granted by Orders dated January 12, 1990 and February 6, 1990, respectively. ITI filed its response to SCB's data request on March 20, 1990.

Subsequently, on May 2, 1990, ITI filed a motion to supplement the tariff by submitting a revised tariff page number 22. SCB has filed no objections with the Commission; therefore, the motion should be granted.

The proposed tariff states that "Bulk Transmission Service is an interLATA only custom switched telecommunications service that offers outward dialed station calling to ITI subscriber locations via the resold facilities of other carriers." It is a flat-rated service and does not utilize the assistance of an ITI operator.¹

In Case No. 10002,² ITI was granted authority to provide interLATA operator-assisted telecommunications services subject to certain restrictions and conditions of service. In granting this authority to operate in Kentucky, the Commission stated:

This authority to provide service is strictly limited to those services described in this Order and contained in ITI's application.

The Commission finds that the Bulk Transmission Service proposed herein is the same type of service authorized by Case No. 10002 less operator assistance and, thus, does not exceed the authority granted ITI in that case.

IT IS THEREFORE ORDERED that ITI's proposed tariff for the provision of Bulk Transmission Service is approved effective on and after the date of this Order.
