### ORDER

On December 21, 1989, West Laurel Water District ("West Laurel") filed its revised tariff with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being sufficiently advised, finds:

- 1. West Laurel purchases its water from Wood Creek Water District ("Wood Creek"). Effective November 22, 1989, Wood Creek increased its rate for water sold to West Laurel from \$1.05 to \$1.15 per 1,000 gallons.
- 2. West Laurel increased the rates to its customers effective January 1, 1990.
- 3. During the 12 months ending November 30, 1989, West Laurel purchased 173,385,200 gallons and sold 147,377,400 gallons.
- 4. West Laurel's calculations are correct and show an increase in purchased water costs of \$17,339 resulting in a purchased water adjustment of \$.12 per 1,000 gallons.
- 5. The purchased water adjustment in the amount of \$.12 per 1,000 gallons and the rates in Appendix A should be approved.

6. The tariff sheet filed by West Laurel is correct and should be approved.

#### IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment in the amount of \$.12 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are approved for services rendered on and after January 1, 1990.
- 2. The tariff sheet filed by West Laurel is hereby approved.
- 3. Within 30 days of the date of this Order, West Laurel shall file a copy of the notice to its customers and verification that such notice has been given.
