ORDER

On July 5, 1990, Marion County Water District ("Marion") filed with the Commission a tariff proposing to establish a changeover fee, returned check charge, collection and reconnection fee, and a 10 percent late penalty charge. Marion also proposed an increase in its meter connection charges for 5/8 x 3/4 inch, 1 inch, and 2 inch size meters. On July 23, 1990, the Commission issued a letter requesting additional information concerning certain filing deficiencies be filed within 15 days. On August 7 and August 22 Marion filed its response to the deficiency letter. Finally, Marion filed a copy of its Affidavit of Publication on September 7, 1990, verifying that the notice to customers was published in the Lebanon Enterprise on August 22, August 29, and September 5, 1990.

Marion has filed schedules with the Commission that itemize the expenses involved in establishing a changeover fee, returned check charge, collection and reconnection fee, and a 10 percent penalty charge. Marion also filed schedules for its proposed meter connection charges. A review of these schedules indicates

that each proposed charge is equal to the expense of the charge and the individual expenses are reasonable.

The Commission, having considered the evidence and being sufficiently advised, HEREBY ORDERS that:

- 1. Marion is hereby permitted to establish a changeover fee, returned check charge, collection and reconnection fee, and a 10 percent penalty charge for late payments as set out in Appendix A, which is attached hereto and incorporated herein.
- 2. Narion is hereby permitted to increase its metered connection fees for a $5/8 \times 3/4$ inch, 1 inch, and 2 inch size meters as set out in Appendix A.
- 3. Within 30 days from the date of this Order, Marion shall file its revised tariff sheets setting out the charges approved herein.
