O R D E R

On July 27, 1990, Pulaski County Water District No. 2 ("Pulaski County") filed revised tariff sheets with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being sufficiently advised, finds that:

1. Pulaski County's supplier, the city of Somerset, increased its rate for wholesale water from \$1.25 to \$1.55 per 1,000 gallons effective June 28, 1990.

2. During the 12 months ending May 31, 1990, Pulaski County purchased 115,162,500 gallons of water and sold 104,474,400 gallons.

3. Pulaski County proposed to place its rates into effect for services rendered on and after August 15, 1990. However, the notice filed by Pulaski County stated the increased rates would be effective with issuance of the Commission's Order. Pulaski County should revise its notice to show the correct effective date of the increased rates.

4. Pulaski County correctly calculated the increase in purchased water costs as \$34,549. The correct purchased water adjustment is 33 cents per 1,000 gallons of water.

5. The purchased water adjustment of 33 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein

6. The tariff sheets filed by Pulaski County are correct and should be approved as filed.

IT IS THEREFORE ORDERED that:


1. The purchased water adjustment of 33 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated, are hereby approved for services rendered on and after August 15, 1990.

2. The tariff sheets filed by Pulaski County are approved as filed.


3. Within 20 days of the date of this Order, Pulaski County shall file verification that the revised notice to its customers has been given.

The following rates and charges are prescribed for the customers in the area served by Pulaski County Water District No. 2. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

Residential

First 1,000 gallons	\$6.93 Minimum Bill
Next 9,000 gallons	2.83 per 1,000 gallons
Over 10,000 gallons	2.43 per 1,000 gallons

Large Business Establishments

<u>1 Inch Meter</u>	
First 5,000 gallons	\$18.25 Minimum Bill
Next 5,000 gallons	2.83 per 1,000 gallons
Over 10,000 gallons	2.43 per 1,000 gallons

School and Factory

<u>2 Inch Meter</u>	
First 20,000 gallons	\$56.70 Minimum Bill
Over 20,000 gallons	2.43 per 1,000 gallons
