On October 22, 1990, Southern Madison Water District ("Southern Madison") filed its revised tariffs with the Public Service Commission ("Commission") pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds:

1. Southern Madison purchases water from Berea College Water Utility ("Berea"). On October 3, 1990, Berea increased its rate for water sold to Southern Madison from $\$ 1.15$ to $\$ 2.82$ per 1,000 gallons pursuant to the provisions of KRS 278.190(2). Subsequently, on November 19, 1990, the Commission entered an Order in Case No. 90-0521 granting an increase in Berea's rate for wholesale water from $\$ 1.15$ to $\$ 1.95$ per 1,000 gallons, and ordering Berea to refund any rates collected between October 3, 1990 and November 19, 1990 in excess of the rates authorized therein.

[^0]2. Southern Madison increased the rates to its customers effective October 3, 1990.
3. During the 12 months ending September 30 , 1990, Southern Madison purchased 276,039,600 gallons of water and sold 134,373,900 gallons.
4. The purchased water adjustment and the rates contained in the tariff filed by Southern Madison are incorrect in that they were based on the $\$ 2.82$ rate imposed by Berea on October 3, 1990 rather than the $\$ 1.95$ rate approved by the Commission's November 19, 1990 Order.
5. The correct increase in purchased water costs is \$140,832, resulting in a purchased water adjustment of $\$ 1.05$ per 1,000 gallons.
6. The purchased water adjustment of $\$ 1.05$ per 1,000 gallons and the rates in Appendix $A$, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Southern Madison are denied.
2. The purchased water adjustment of $\$ 1.05$ per 1,000 gallons and the rates in Appendix A are approved for services rendered on and after October 3, 1990.
3. Within 30 days of the date of this order, Southern Madison shall refund to its customers any revenue collected as a result of the purchased water adjustment in excess of the amount allowable under the rates approved herein. Within 10 days thereafter, Southern Madison shall file a schedule with the

Commission showing the dates of refunds, the amounts of refunds, and the names of customers to whom refunds are made.
4. Within 30 days of the date of this Order, Southern Madison shall file its revised tariff sheet setting out the rates approved herein.
5. Within 20 days of the date of this Order, Southern Madison shall file a copy of the notice to its customers and verification that such notice has been given.
