O R D E R

On November 26, 1990, the Commission initiated this investigation to determine whether persons who own, control, operate or manage customer-owned, coin-operated telephones ("COCOTs") are utilities as defined by KRS 278.010. The Commission had determined in Administrative Case No. 293<sup>1</sup> in 1986 that COCOTs were not utilities. Local Exchange Carriers ("LECs") were required to file COCOT tariffs and the Commission regulates COCOT service through the tariffs of the LECs. However, since 1986, there have been many changes in COCOT service and they perform functions clearly not contemplated at the time the Commission determined that COCOTs were not utilities.

The Commission made Coin Phones, Inc. and Coin Phone Management Company ("Coin Phone Management") parties to the proceeding since both entities had filed with the Commission an

application for a Certificate of Public Convenience and Necessity.<sup>2</sup> These applications were held in abeyance pending the outcome of this case. Additionally, the Commission sent a copy of the initiating Order to all parties known to the Commission that purchase COCOT access from Kentucky LECs. All LECs were also served with a copy of the Order.

The following have requested and been granted intervention in this proceeding: the Attorney General, by and through his Utility and Rate Intervention Division ("AG"), South Central Bell Telephone Company ("South Central Bell"), AmeriCall Dial-0 Services ("Dial-0"), US Sprint, Cincinnati Bell Telephone Company ("CBT"), MCI Communications Corporation ("MCI"), and Intellicall, Inc. ("Intellicall"), and the Kentucky Telephone Association ("KTA"). The Commission's November 26, 1990 Order requested comments and the following have filed comments addressing issues in this proceeding: AG, Intellicall, Coin Phone Management, Dial-0, CBT, GTE South Incorporated ("GTE South"), and South Central Bell.

On February 28, 1991, the Commission, by Order, scheduled an informal conference for March 14, 1991. The conference had been requested by Intellicall and Coin Phone Management to demonstrate a "store and forward" payphone.

By Order dated April 9, 1991, the Commission stated that no additional information was needed at this time prior to entering an Order determining the utility status of COCOT providers. Therefore, the Commission would enter an Order without a hearing or further comments unless a request for a hearing or additional comments were received by the Commission within 20 days. No request for hearing or additional comments were received in response to this Order.

#### DISCUSSION

This proceeding was established to consider the following issues:

1. Whether persons who own, control, operate, or manage COCOTs meet the definition of a utility as found in KRS 278.010(3)(e).

2. If the Commission determines that COCOTs meet the statutory definition of utilities, then should they be considered dominant or non-dominant?

3. If COCOTs are deemed to be non-dominant utilities, then what is the appropriate regulatory scheme?

In Administrative Case No. 293, the Commission stated that whether COCOT providers were public utilities was a difficult issue but found that they were not utilities. The basis of the Commission's conclusion was that regulation of COCOT providers through the tariffs of LECs would be adequate. Also, the Commission noted that it anticipated a limited scope of operations for COCOT providers.<sup>3</sup>

## ARE COCOT PROVIDERS UTILITIES?

The first issue is whether COCOTs meet the statutory definition of a public utility. KRS 278.010(3)(e) states:

Utility means any person except a city, who owns, controls or operates or manages any facility used or to be used for or in connection with. . . [t]he transmission or conveyance over wire, in air or otherwise, of any message by telephone or telegraph for the public, for compensation.

Facility is defined by KRS 278.010(9) as follows:

Facility includes all property, means and instrumentalities owned, operated, leased, licensed, used, furnished or supplied for, by, or in connection with the business of any utility.

Therefore, in order for COCOT providers to be classified as a utility, it must be found that: (1) they own, control, or operate or manage any facility used in the transmission of telephone messages; (2) the transmission of telephone messages is for the public; and (3) the transmission of the telephone messages is for compensation. COCOT providers meet all three criteria.

COCOT providers include payphones that are both coin operated and non-coin operated. Today, COCOTs range in technology from the older unsophisticated telephones that restrict the method of payment to coins, referred to herein as "coin-only" payphones, to the more recent technology that has created COCOTs which are often referred to as "smart" payphones utilizing "store and forward" technology. When using a COCOT which only accepts coins, end-users desiring to pay on credit are, out of necessity, routed to LECs or operator service providers. The "smart" COCOTs or "store and forward" payphones enable the end-users to pay by

credit without the need to access operator-assisted services from the LECs or any other utility. Through the use of advanced microprocessor and telecommunications technology, these newer phones are able to complete and bill for both sent paid (cash) and non-sent paid (credit) calls placed to local and long-distance locations. For non-sent paid calls, end-users may elect to pay by charging the call to a calling card or by charging the call to the called number.

Most COCOT providers purchase the fully assembled payphones from the manufacturer and then install and maintain these COCOTs at various locations within the Commonwealth by entering into contractual agreements with the entity owning or leasing the premises upon which the payphone is located. There can be little doubt COCOT providers have the capability to basically function no differently than resellers currently under the Commission's jurisdiction.

The evidence of record establishes that COCOT providers own, control, operate and manage facilities used for and in connection with the transmission of telephone messages. The COCOT providers own and/or operate the telephone instruments that are used to initiate the calls and in the case of the new technology telephones, provide the operator services and billing information for the calls. While COCOT providers do not own the transmission lines, they resell transmission lines obtained from LECs and other authorized interexchange carriers much like the resellers certified by the Public Service Commission. Dial-0 argues to the Commission that such an interpretation is not correct and urges

the Commission to take a very narrow and limiting definition of the requirement to own or operate facilities. Dial-0 cites the Commission to Certification of Resellers, Docket No. M-84041, (Pa. PUC June 18, 1990) in which the Pennsylvania Commission determined that it lacked jurisdiction over resellers of interexchange services due to the fact that those entities did not hold legal title to the lines. The jurisdiction conferred upon the Kentucky Public Service Commission pursuant to KRS 278.010 is extremely broad and certainly reaches beyond entities that merely hold legal title to facilities. Specifically, the definition of facility includes "all property . . . owned, operated, leased, licensed, used, furnished or supplied for, by, or in connection with the business of any utility." There can be no doubt that COCOT providers own, control, operate, or manage facilities used in connection with the transmission of telephone messages.

Likewise, the evidence of record establishes that COCOT providers meet the second and third criteria of the statutory definition of a utility. COCOT providers operate facilities used in connection with the transmission of telephone messages for the public and for compensation. Contrary to the Commission's past decision in Administrative Case No. 293, the evidence in this record is uncontested that COCOT providers offer and provide service to the general public at large. There are a large number of COCOTs in Kentucky; Coin Phone Management has estimated the

total number of non-LEC owned payphones to be 2,500.<sup>4</sup> These COCOTs are located in large public facilities such as airports, hotel lobbies, hospitals, as well as local street corners, all of which are made available to the public at large. The evidence of record is equally undisputed that COCOT providers receive compensation for the service offered. In fact, the evidence establishes that with the new technology, the public has more options available as to the form of compensation when using COCOTs. COCOTs are not entirely restricted to coin-operated only, but as indicated earlier, consumers can compensate the COCOT by use of credit cards, as well as third party billing.

ARE COCOT UTILITIES NONDOMINANT?

The second issue to be addressed by the Commission is whether or not COCOT providers should be treated as non-dominant carriers. All parties filing comments in this proceeding agreed that if COCOTs are utilities, they should be regulated as the Commission regulates non-dominant carriers. The evidence in the record establishes that COCOT providers' share of the pay station market is nowhere near as substantial as AT&T's or the LECs. None of the factors which led the Commission to the conclusion that AT&T<sup>5</sup>

and later the LECs<sup>6</sup> should be considered dominant are applicable to the COCOT providers. Therefore, in establishing the appropriate regulatory scheme, the Commission will consider COCOT providers as non-dominant.

Although COCOT utilities are nondominant in terms of their share of the pay station market, it may be possible for COCOT utilities to engage in anti-competitive behavior in some instances. The Commission will address these instances on a case-by-case basis as they become known, primarily through customer complaints.

#### ARE CERTAIN CONDITIONS FOR SERVICE NECESSARY?

The third issue is the determination of an appropriate regulatory scheme suitable for all COCOT utilities. The AG suggests in his comments that the Commission promulgate regulations for the provision of COCOT service in Kentucky. COCOT providers are public utilities and therefore will be subject to the same Commission regulations as all other public utilities. The Commission does not need to promulgate regulations specifically tailored to COCOT providers at this time.

The tariffing of specific conditions of service is necessary for COCOTs to be providing reasonable service at fair, just, and reasonable rates.

1. Requirements for COCOT Access in  
LEC Tariffs.

Certain conditions of service which are to be common to the provision of all COCOT service are appropriate to be included in the LECs' tariffs, since all COCOT providers obtain access to the network by purchasing access from the LECs.

Accordingly, the LEC tariffs need to require the following as a condition for the provision of local access to all payphones:

(1) COCOTs shall post on or near the payphone the name and phone number of owner of the instrument.

(2) COCOTs shall post on or near the payphone the operating instructions for the instrument.

(3) COCOTs shall provide and post on or near the instrument a cost-free method for reporting complaints and obtaining refunds.

(4) COCOTs that accept coins shall accept coins of various denominations and shall be capable of returning unused coins.

(5) COCOTs shall not charge for calls not completed.

(6) COCOTs shall provide access to 911 Emergency Service (where available) free and without the use of a coin.

(7) COCOTs shall be FCC registered, hearing aid compatible, and meet federal requirements for size of digits on the instrument.

(8) COCOTs shall be mounted in accordance with federal height regulations for disabled persons.

(9) COCOTs that provide access to long-distance service shall offer access to all certified long-distance carriers through 1-700, 1-800, 1-950, or 10XXX dialing.

(10) COCOTs shall offer toll-free access to 800 numbers.

(11) COCOTs shall not be connected behind a PBX.

The Commission does not intend for LECs to police the COCOT industry to ensure the continuing compliance of their tariff provisions. The Commission will address complaints about COCOT service through its established procedures.

2. Additional Requirements Based on  
Deployment of Technology.

Additional requirements may be necessary for certain COCOT providers. Those providers furnishing long-distance toll services should comply with the operator service provider restrictions developed in Administrative Case No. 330,<sup>7</sup> as set forth below. On the other hand, those providers that only furnish access to the network may be regulated via the LECs' COCOT access tariff.

- a. Payphones, including "smart" COCOTs, that provide long distance toll services.

All COCOT providers furnishing long-distance toll services, including "smart" COCOTs and "coin only" COCOTs, because of their similarity to resellers and alternate operator providers need certain conditions of service in addition to complying with the LECs' COCOT access tariff conditions in order for the service to be reasonable.

All of the parties, except for Dial-0, suggested that the Commission apply the same restrictions to the provision of service

to COCOT providers as the Commission has established in Administrative Case No. 330, which applied to alternate operator service providers. In fact, COCOT providers using the new technology described herein eliminate and take the place of operator services. Therefore, "smart" COCOT providers and others providing toll services need further restrictions in order for the services to be reasonable and in the public interest. As stated in Administrative Case No. 330, the following restrictions are necessary for the provision of the above-described COCOT service to be reasonable and avoid potential wrongdoing to end-users that may occur due to the absence of a preestablished relationship between the provider and the end-user.

Accordingly, COCOT providers furnishing toll calls:

(a) shall not charge rates that exceed AT&T's maximum approved rates for interLATA calls and, upon implementation of intraLATA competition pursuant to Administrative Case No. 323, Phase I, LEC rates for intraLATA calls. "Maximum approved rates" is defined to mean the rates approved by this Commission in AT&T's and LECs most recent rate proceeding for measured toll service applicable to operator-assisted calls, as well as the additional charges for operator assistance. These COCOT providers are not permitted to include any other surcharges or to bill for uncompleted calls. Time-of-day discounts shall also be applicable. These providers are also required to rate calls using the same basis that AT&T or the LECs use to rate calls, i.e., distance calculations based on points-of-call origination and termination, definitions of chargeable times, billing unit

increments, rounding of fractional units, and minimum usages. When there is any change in AT&T's maximum approved rates or any applicable LEC rate, these providers shall file tariffs, within 30 days of the effective date of AT&T's or LECs' rate change, if necessary, to comply with the requirements herein.

(b) shall not allow access to the services of competing carriers to be blocked or intercepted. Blocking and interception prohibitions shall be included in all tariffs for COCOTs providing toll service and all contracts entered into with any traffic aggregator and shall state that violators will be subject to immediate termination of service after 20 days' notice to the owners of non-complying customer premises equipment.

(c) Access to the local exchange carrier's operators shall not be blocked or otherwise intercepted by these providers or traffic aggregators. Specifically, all "0-" calls, that is, when an end-user dials zero without any following digits, shall be directed to the local exchange carrier operators. In equal access areas, "0+"<sup>8</sup> intraLATA calls shall not be intercepted or blocked. In non-equal access areas, it is prohibited to block or intercept "0-" calls; however, it is permissible to intercept "0+" calls. Blocking and interception prohibitions shall be included in all tariffs filed by these COCOTs and all contracts entered into with any traffic aggregator and shall state that violators will be subject to immediate termination of service after 20 days' notice

to the owners of non-complying customer premises equipment to which the COCOT providing toll service is presubscribed for operator services.

(d) shall not be required to provide access codes of competitors.

(e) shall provide stickers to be placed near or on its telephone equipment, and shall include provisions for said stickers in its tariffs and contracts entered into, specifying the name, address, and telephone number of the entity presubscribed for operator services, with any traffic aggregator that subject violators to immediate termination of service after 20 days' notice to the owners of non-complying customer premises equipment.

(f) shall require that if an operator service provider rates and bills calls, then the operator service provider must be identified to end-users at least once during every call before any charges are incurred.

(g) shall provide a way for any caller, upon request, to be informed as to the applicable rates.

(h) shall not accept calling cards for billing purposes if they are unable to validate the card.

b. Coin-Only payphones that merely provide access to the network.

"Coin-only" COCOT utilities that provide only access to the network because of the limited service provided do not have to file a tariff listing their charges for service if they charge end-users the identical rate for a local call as would be charged from a LEC operated coin telephone in the same locale. Any

coin-only payphone utility providing only access that wishes to charge a rate different from the rate for a local call from the LEC-operated payphones in its locale shall file a tariff containing its rates.

Therefore, each LEC tariff for COCOT access should also contain a provision to enable those coin-only COCOT utilities providing only access to mirror the LEC operated payphone rate for a local call. All LECs shall provide the following language in their tariff: Coin-only COCOTs that only provide access to the network and do not have a separate approved tariff on file with the Commission shall only charge the LEC operated payphone rate referenced in the LECs' tariff.

The Commission, having considered the record and being otherwise sufficiently advised, HEREBY ORDERS that:

1. All COCOT providers are utilities as defined in KRS 278.010 and shall be regulated by this Commission in accordance with the Commission's applicable laws and regulations. Appendix A, attached hereto and incorporated herein, contains a listing of all COCOT providers known to the Commission to be operating in Kentucky.

2. Within 30 days of the date of this Order, all LECs shall file COCOT access tariffs detailing the requirements specified herein.

3. LECs shall provide billing and collection services to COCOT utilities on the same basis as provided to all utilities.

4. Any COCOT providers furnishing toll service in Kentucky, including "smart" payphones, shall file a tariff containing its

rates and all conditions of service enumerated herein within 60 days of the date of this Order.

5. Any coin-only COCOT provider furnishing only access to the network that proposes to provide service at a rate other than the rate of the LEC-operated payphones in its locale shall file a tariff containing its rates within 60 days of the date of this Order.


6. All COCOTs shall file an annual report with this Commission by March 31, 1992 and each year thereafter in the format contained in Appendix B, attached hereto and incorporated herein.

7. Any COCOT not currently providing service and desiring to provide toll services shall file a proposed tariff, which must be effective prior to the COCOT operating in Kentucky. All COCOTs currently providing service may continue to do so in accordance with the requirements enumerated herein.
