O R D E R

On April 26, 1991, Central Kentucky Cellular Telephone Company ("Central Kentucky Cellular") filed an application seeking a Certificate of Public Convenience and Necessity to construct and operate an additional cellular radio telecommunications antenna tower in the Lexington, Kentucky Metropolitan Statistical Area ("Lexington MSA"). The Commission previously granted Central Kentucky Cellular authority to provide cellular services in the Lexington MSA.

The proposed cell facility will improve Central Kentucky Cellular's existing services and will increase the system's capacity to provide service to new customers. This cell facility will be located at the west side of Paynes Hill Road, approximately one-half mile Northeast of U.S. 60 and about one mile east of Versailles in Woodford County, Kentucky. Central Kentucky Cellular is leasing the property on which the tower is to be located. There are no structures within 500 feet of the

proposed cell site. All property within a 500 foot radius of the proposed tower site is owned by the lessor. The height of the antenna tip above ground level is to be 298 feet.

Central Kentucky Cellular has provided information regarding the structure of the tower, safety measures, and antenna design criteria. Based upon the application, the tower and foundation design appear to meet the criteria of the Building Officials and Code Administrators International, Inc. (BOCA) National Building Code, with reference to earthquakes, winds, and tornadoes.


Pursuant to KRS 100.324(1), the proposed cell site construction is exempt from local zoning ordinances. However, Central Kentucky Cellular has notified the Woodford County Planning and Zoning Commission of its proposed construction by letter dated April 26, 1991. The Federal Communications Commission ("FCC") has already granted Central Kentucky Cellular authority to operate in the Lexington MSA. On March 14, 1990, Central Kentucky Cellular filed applications with the Federal Aviation Administration ("FAA") and the Kentucky Airport Zoning Commission ("KAZC"). The FAA approved the proposed construction on May 21, 1991. The KAZC approved the application on March 21, 1991.


The Commission, having considered the evidence of record and being otherwise sufficiently advised, HEREBY ORDERS that Central Kentucky Cellular be and it hereby is granted a Certificate of Public Convenience and Necessity to construct a 298 foot cellular radio telecommunications antenna tower in the Lexington MSA, at the west side of Paynes Mill Road, approximately one-half mile

Northeast of U.S. 60 and about one mile east of Versailles in Woodford County, Kentucky.


