At the informal conference held June 20, 1991 it was agreed by those present that Commission Staff would calculate a factor to be applied to AT&T Communications of the South Central States. Inc. ("AT&T") traffic data between Georgetown, Kentucky and Lexington, Kentucky filed in this proceeding. The information is intended to be used by local exchange carriers ("LECs") to produce amount representing all interLATA carrier traffic between Lexington. In calculating the factor the Georgetown and Commission Staff utilized information filed by interLATA carriers on a regular basis which the Commission has already ordered to be protected from public disclosure pursuant to 807 KAR 5:001, Section 7.1 Accordingly, the factor from which AT&T's interLATA market share for Kentucky may be derived should be held and retained by this Commission as confidential and should not be opened for public inspection.

Case No. 8838, An Investigation Of Toll And Access Charge Pricing And Toll Settlement Agreements For Telephone Utilities Pursuant To Changes To Be Effective January 1, 1984, Order dated January 23, 1991.

The Commission, having been otherwise sufficiently advised, HEREBY ORDERS that:

- 1. The market share factor calculated by Commission Staff shall be withheld from public disclosure and retained by this Commission as confidential.
- 2. Upon receipt of a confidentiality agreement executed between AT&T and South Central Bell Telephone Company and a confidentiality agreement executed between AT&T and GTE South Incorporated, the Commission shall provide to GTE South and South Central Bell, by certified mail, an unedited copy of the information which is incorporated as Appendix A and attached hereto.
