O R D E R

On July 12, 1991, South Central Bell Telephone Company ("South Central Bell") filed a proposed tariff for Area Calling Service ("ACS"). By Order dated July 30, 1991, the ACS tariff was suspended until January 11, 1992, for proceeding to determine its reasonableness. The Attorney General ("AG"), by and through his Utility and Rate Intervention Division, AT&T Communications of the South Central States, Inc. ("AT&T"), MCI Telecommunications, Inc. ("MCI"), and AmeriCall Systems of Louisville ("AmeriCall") have filed motions to intervene. All of these motions have been granted.

Accompanying SCB's proposed tariff was a motion to deviate from certain Commission rules. SCB has requested a waiver from the financial exhibit requirements of 807 KAR 5:001, Section 10(1)(a), and the description of property requirement of 807 KAR 5:001, Section 10(1)(c). Compliance with these requirements is not necessary for the review of ACS and, therefore, SCB's request for a deviation should be granted.

In addition, SCB has requested a waiver from the customer notice requirement of 807 KAR 5:011, Section 8. Because of the

possibility for increased rates for certain customers, this deviation should not be granted. SCB should notify, by an appropriate manner, those customers who may be impacted.

The Commission, having been otherwise sufficiently advised, HEREBY ORDERS that:

1. SCB's motion to deviate from 807 KAR 5:001, Section 10(1)(a) and 10(1)(c), shall be granted.

2. SCB's motion to deviate from 807 KAR 5:011, Section 8, shall be denied. SCB may, at its option, use abbreviated customer notice.

3. The following procedural schedule shall be adopted:

SCB shall file testimony specifically addressing its compliance with the Commission's requirements for the provision of local measured service as set forth in the October 25, 1990 Order in Administrative Case 285,¹ and shall be due no later than..... 10/11/91

Intervenors shall file testimony specifically addressing SCB's compliance with the requirements for the provision of local measured service as set forth in the 10/25/90 Order in Administrative Case No. 285, and shall be due no later than..... 10/25/91

Data Request to all parties shall be due no later than..... 11/04/91

Responses to data requests shall be due no later than..... 11/14/91

Public Hearing to begin at 10:00 a.m., Eastern Standard Time, in Hearing Room 1 of the Commission's offices at 730 Schenkel Lane, Frankfort, Kentucky..... 11/19/91
