ORDER

IT IS ORDERED that CTG Telecommunications, Inc. ("CTG") shall file the original and ten copies of the following information with the Commission. The information requested shall be placed in a bound volume with each item tabbed. Include in each response the name of the witness who will be responsible for responding to questions relating to the information provided.

The information requested herein is due no later than 30 days from the date of this Order. If the information cannot be provided by this date, CTG shall submit a motion for an extension of time stating the reason a delay is necessary and include a date by which it can be furnished. Such motion will be considered by the Commission.

l. Has CTG or any of its affiliates ever provided and/or collected any money from the public for the provision of intrastate telecommunications services in Kentucky? If so, explain in detail.

- 2. If CTG intends to resell tariffed services of facilities-based carriers, identify these tariffed services and specify whether these services will be obtained from intrastate or interstate tariffs.
- 3. If CTG intends to resell services that are not available under an approved tariff, provide copies of the contracts which govern the terms of the agreement between CTG and its facilities-based carriers.
- 4. Clarify whether or not CTG is seeking intraLATA operating authority.
- 5. Explain how CTG will screen intraLATA traffic if CTG intends to resell services or facilities authorized only for interLATA traffic but which can carry intraLATA traffic.
- 6. Does CTG own and/or operate any transmission facilities in any jurisdiction? If so, explain.
- 7. Does CTG have any affiliation with any other company which owns and/or operates any transmission facilities in any jurisdiction? If so, explain.
- 8. Refer to Original Sheet No. 8 of CTG's proposed tariff.
 Regarding "CTG Switched Interconnection Mode," where is this switch located?
- 9. Refer to page 4, Item 6 "Services to be Offered," of the application. It is stated that "AOS" will not be provided by CTG. Assuming "AOS" represents operator-assisted services ("OAS"), explain in detail how operator-assistance will be provided.

- 10. State whether CTG is aware that any special/dedicated access services shall be provided under the following conditions:
- a. CTG shall measure and report interstate and intrastate jurisdictional usage and interLATA and intraLATA usage.
- b. CTG shall inform its prospective customers that the Commission has not authorized it to market or tariff these services to complete intraLATA calls.
- c. CTG shall be prepared to compensate local exchange carriers for unauthorized intraLATA call completion.
- 11. Provide estimates of sales revenues for CTG's first two years of Kentucky operations. Explain how CTG arrived at these estimates. If estimates are based upon a market study, provide a copy of this study.
- 12. Provide a listing of financial institutions with which CTG has a line of credit. State CTG's credit line with each of these institutions.
- 13. State whether CTG is aware of the potential impact of Administrative Case Nos. 323¹ and 328,² now pending before this Commission, that may apply to CTG's Kentucky operations.

Administrative Case No. 323, An Inquiry Into IntraLATA Toll Competition, An Appropriate Compensation Scheme for Completion of IntraLATA Calls by Interexchange Carriers, and WATS Jurisdictionality.

Administrative Case No. 328, Investigation Into Whether WATS Resellers Should Be Included in the ULAS Allocation Process.
