O R D E R

Pursuant to Commission Order, an informal conference was held on November 14, 1991 for the purpose of establishing dates for a procedural schedule and discussing preliminary technical and administrative issues related to Kentucky Utilities Company's ("KU") 1991 Integrated Resource Plan. In attendance were representatives of KU, the Attorney General's Utility and Rate Intervention Division, and the Commission's Staff. At that conference, the parties agreed unanimously to the dates shown on the procedural schedule appended to this Order. The parties also agreed that the discovery process in this case would be greatly facilitated and expedited if the record of Case No. 91-115<sup>1</sup> was incorporated by reference into this case.

Pursuant to Section 12 of 807 KAR 5:058, which requires the Commission to develop a procedural schedule for review of KU's

plan, the Commission finds that the procedural schedule agreed to by the parties should be adopted.

IT IS THEREFORE ORDERED that:

1. The procedural schedule appended hereto shall be followed.

2. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the person responsible for responding to the question. All requests for information, responses, comments, and reply comments shall be received no later than the dates shown on the appended procedural schedule, with copies to all parties of record and 16 copies to the Commission.

3. The record of Case No. 91-115 shall be incorporated by reference into the instant case.
