# ORDER

On December 7, 1990, the Commission issued its Order in Case No. 90-076 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates on a quarterly basis in accordance with the provisions of the gas cost adjustment ("GCA") clause set forth therein.

On December 24, 1991, Elzie Neeley Gas Company, Inc. ("Elzie Neeley") filed its quarterly GCA, which is to become effective February 1, 1992 and is to remain in effect until April 30, 1992.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Elzie Neeley's notice of December 24, 1991 set out certain revisions in rates which Elzie Neeley proposed to place into effect, said rates being designed to pass on to its customers the expected wholesale change in gas cost from its supplier. Elzie Neeley did not use the most currently available supplier rate in its calculation; hence, its proposed rates should be denied.

- 2. Elzie Neeley's expected gas cost ("EGC") adjustment for the quarter beginning February 1, 1992 should be \$3.8848 per Mcf based on its supplier rate effective September 1, 1992.
- 3. Elzie Neeley's notice included no actual adjustment. This adjustment will be unavailable to Elzie Neeley until its GCA clause has been in effect for two quarters.
- 4. The combined effect of the above adjustments is Elzie Neeley's gas cost recovery rate ("GCR") in the amount of \$3.8848 per Mcf, an increase of 2.96 cents per Mcf from its last approved rates.
- 5. The rates set out in the Appendix to this Order, pursuant to the GCA provisions approved by the Commission in its Order in Case No. 90-076 dated December 7, 1990, are fair, just, and reasonable, in the public interest, and should be effective with gas supplied on and after February 1, 1992.

## IT IS THEREFORE ORDERED that:

- The rates proposed by Elzie Neeley be and they hereby are denied.
- 2. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable and are approved effective with gas supplied on and after February 1, 1992.
- 3. Within 30 days of the date of this Order, Elzie Neeley shall file with this Commission its revised tariffs setting out the rates authorized herein.
