ORDER

The Commission, on its own motion, established this case to serve as a depository for Reports on Minutes of Use by Service. All intraLATA dominant and non-dominant carriers were required by Administrative Case No. 323¹ to file reports on intraLATA minutes of use (Kentucky jurisdictional) by service with this Commission on a quarterly basis. The purpose of these reports is to assist the Commission in evaluating the evolution of the intraLATA toll market.

Simultaneously, the Commission found that interLATA dominant and non-dominant carriers were directed to file reports on interLATA minutes of use (Kentucky jurisdictional) by service with the Commission on a quarterly basis. The information is being used to evaluate the continuing changes in the interLATA toll market. In the Order of June 11, 1991, the Commission also

recognized the sensitive nature of this information and granted it confidentiality.

On February 27, 1992, the Commission ordered all carriers under its jurisdiction to file intraLATA and interLATA reports on minutes of use, number of messages, and amount of revenues for the residential market and business market secments. The Commission's Order of April 7, 1992 granted motions for further investigation. On June 11, 1992, the Commission issued an order requesting additional information. The responses to the data request indicated that the majority of Local Exchange Carriers ("LECs") do not maintain the requested data by market segment. Although only three LECs, South Central Bell Telephone Company ("SCB"), GTE South Incorporated ("GTE South") and Brandenburg Telephone Inc. ("Brandenburg Telephone"), maintain data by market Company, segment these companies serve a significant percentage of the market. The remaining LECs serve a much smaller percentage of customers and represent a small percentage of market share.

For these reasons the Commission will require those companies that already maintain data by market segment to provide this data to the Commission on a quarterly basis. Those companies that are not currently maintaining data by residential market and business market segments will not be required to do so at this time.

At the time this case was established all telecommunications carriers were directed to file the requested market share information on a service-by-service basis for each service provided. However, during the interim KRS 278.512 and 278.514 have become effective. As a result the Commission finds that

telecommunications carriers should be prepared to provide market share information on a service-by-service basis as reduced regulation is requested pursuant to KRS 278.512 and 278.514. For this reason the Commission will no longer require telecommunications carriers to file line of service information, but only the total minutes of use, number of messages, and total revenues for the intraLATA and interLATA markets.

IT IS THEREFORE ORDERED that:

1. South Central Bell, GTE South, and Brandenburg Telephone shall file minutes of use, number of messages, and revenues for the residential market and business market segments on a quarterly basis using the format attached hereto and incorporated herein as Appendix C, effective with the report to be filed for the 4th Quarter, 1992.

2. All other telecommunications utilities except Customer-Owned Coin-Operated Telephones shall not be required to maintain data by residential market and business market segments at this time, but shall continue to file reports attached hereto and incorporated herein as Appendix A and Appendix B on a quarterly basis.

3. Telecommunications utilities shall no longer be required to file by line of service their minutes of use, number of messages, and revenues effective with the report to be filed for the 4th Quarter, 1992.
