O R D E R

IT IS ORDERED that Johnson County Gas Company ("Johnson County") shall file the original and 12 copies of the following information with the Commission with a copy to all parties of record no later than 7 days from the date of this Order. Johnson County shall furnish with each response the name of the witness who will be available at any public hearing, if necessary, for responding to questions concerning each item of information requested.

1. Provide a detailed monthly analysis of surcharge revenue that has been billed and collected by Johnson County between November 1990 and June 1992. Also include the Mcf sales related to the amount of revenue reported.
2. Provide the date of the last meeting of the Kentucky Business Trust and state whether a representative from Johnson County was present.
3. Provide the June 1992 general ledger, if available.

4. Explain the increase of \$16,797 in the Plant and Equipment account with the corresponding decrease in Notes Payable - Citicorp as recorded in the May 1992 general ledger.

5. Has Johnson County made any payments on the Department of Local Government loan and/or the Columbia Gas arrearage since the Order of October 30, 1990? If yes, provide copies of the checks.

6. Provide the amount of funds on deposit in a surcharge escrow account as of May 31, 1992 and June 30, 1992. Include the date the account was opened, all deposits and withdrawals from the account since it was opened, and the purpose of each withdrawal.

7. Identify any other accounts which contain funds which could be made available to use toward the repayment of the Department of Local Government loan and the Columbia Gas arrearage. Provide the balance in each account at May 31, 1992 and June 30, 1992.

8. Based on the surcharge revenues identified in Item 1, provide a detailed analysis of the use of the funds which are not identified as being currently available in Items 6 and 7.

9. In the response to Item 7 of the Commission's February 28, 1992 Order, Johnson County provided the amount of increase in three accounts for the 12-month period ending October 31, 1992: Account 161, plant and equipment, pipe; Account 923, outside services, line replacement; and Account 923, outside services, engineering.

a. For each of these three accounts, provide the amount of additional expenses incurred during the period November 1, 1991 through May 31, 1992.

b. Have these expenses been paid? If yes, how much and to whom?

c. Was the material and work represented by these expenses needed due to the relocation of Highway 23?
