ORDER

By Order dated November 25, 1991, the Commission initiated this proceeding to investigate the abandonment of service by K&N Water Service ("K&N"). The Order further directed K&N to continue operation of its water service until it obtained Commission approval of the abandonment. K&N contends its reason for abandonment is that it will not be financially feasible to continue operating the system in compliance with Commission regulations and statutes. K&N further states that its customers will have an alternative source of water supply by drilling wells. At the present time K&N further submits that because of the weather some of the wells have not been drilled, but that it will not discontinue any water service to a customer unless the customer has another source of water. The Commission is sending a copy of this Order to all known customers listed in Appendix A, in order to give these customers an opportunity to intervene or file objecting comments.

The Commission, having been otherwise sufficiently advised, HEREBY ORDERS that:

1. Within 20 days of the date of this Order, any person who wishes to become a party to this proceeding may submit a written request for intervention. Such request shall include the person's name and address.

2. Within 20 days from the date of this Order, any person who wishes to file a written objection to the abandonment may do so. Such objection shall include the person's name and address.
