ORDER

On December 31, 1991, North Shelby Water Company ("North Shelby") filed its revised tariff with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure, KRS 278.012 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

- 1. North Shelby purchases water from the Louisville Water
 Company ("Louisville"), Shelbyville Water and Sewer
 ("Shelbyville"), and the Frankfort Electric and Water Plant Board
 ("Frankfort").
- 2. Effective January 1, 1992, Louisville increased its rate for water sold to North Shelby from \$1.06 per 1,000 gallons to \$1.10 per 1,000 gallons, and increased its \$57.22 monthly service charge to \$58.98. There was no increase to the elevated service area surcharge of \$.19 per 1,000 gallons. There has been no change in the rates charged by Shelbyville and Frankfort. Based on 5,000 gallons average monthly usage, the average monthly bill

- for a North Shelby customer will increase from \$20.90 to \$20.95, which is an increase of .24 percent.
- 3. North Shelby proposes to increase the rates to its customers effective January 15, 1992.
- 4. During the 12 months ending November 30, 1991, North Shelby purchased a total of 314,276,030 gallons of water, 116,990,000 gallons of which were purchased from Frankfort, 66,587,000 gallons of which were purchased from Louisville, and 130,699,030 gallons of which were purchased from Shelbyville.
- 5. North Shelby sold 244,336,919 gallons of water during the same 12-month period.
- 6. Due to the use of an incorrect rate base, North Shelby's purchased water adjustment factor is incorrect. The increase in the cost of purchased water is \$2,685, resulting in a purchased water adjustment of 1 cent per 1,000 gallons as shown in Appendix B.
- 7. The purchased water adjustment of 1 cent per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by North Shelby are denied.
- 2. The purchased water adjustment of 1 cent per 1,000 gallons and the rates in Appendix A are approved for services rendered on and after January 15, 1992.

- 3. Within 30 days of the date of this Order, North Shelby shall file its revised tariff sheet setting out the rates approved herein.
- 4. Within 20 days of the date of this Order, North Shelby shall file verification that notice has been given to its customers.
