## ORDER

IT IS ORDERED that Jackson Purchase Rural Electric Cooperative Corporation ("Jackson Purchase RECC") shall file the original and 12 copies of the following information with the Commission with a copy to all parties of record no later than 20 days from the date of this Order.

1. a. Provide a copy of Jackson Purchase RECC's present safety program and all published safety policies.

b. State the date when Jackson Purchase RECC established its safety program.

c. List all changes to Jackson Purchase RECC's safety program since its establishment.

2. a. State whether William Scott had violated any Jackson Purchase RECC's work rule prior to November 1, 1991.

b. If yes, state the date of each violation, its nature, and any disciplinary action which Jackson Purchase RECC took against Scott.

3. a. State the length of Scott's employment with Jackson Purchase RECC.

b. List all positions with Jackson Purchase RECC which Scott has held and describe each position's duties.

4. a. State the length of Howard Puckett's employment with Jackson Purchase RECC.

b. List all positions with Jackson Purchase RECC which Puckett has held, his length of service at each position, and each position's duties.

5. a. State whether Jackson Purchase RECC has taken any disciplinary action against Puckett or Scott for the November 1, 1991 incident.

b. If yes, describe the nature of that action(s).

6. a. Explain how Jackson Purchase RECC ensures that its foremen and supervisors enforced Jackson Purchase RECC's work rules.

b. If these procedures are published, provide a copy.

c. State the date each procedure was established.

d. Identify the Jackson Purchase RECC employee(s) responsible for ensuring foremen and supervisors enforce Jackson Purchase RECC work rules.

7. a. Describe what Puckett was doing when Scott was injured.

b. State where Puckett was located when Scott was repairing the downed line.

c. State the distance between Puckett and Scott when the incident occurred.

8. a. State whether any other Jackson Purchase RECC employees were present when Scott was injured.

b. Identify these employees and state their position with Jackson Purchase RECC.

9. Describe weather conditions at time of accident.

10. State the procedures which Scott used to determine that the 3-phase line was not energized.

ll. a. Describe Scott's injuries and the medical treatment which he received for them.

b. State number of work days lost because of the incident.

c. State the date when Scott returned to work.

12. Describe Jackson Purchase RECC's actions since the incident to prevent similar incidents.

13. Describe the discipline measures which Jackson Purchase RECC may take against employees who have violated its work rules.

14. a. List all incidents since 1985 where Jackson Purchase RECC has found an employee to have violated its work rules.

b. For each incident, state the disciplinary measures which Jackson Purchase RECC took.
