O R D E R

On August 14, 1992, Clark Rural Electric Cooperative Corporation ("Clark") filed a motion requesting the Commission extend to September 2, 1992 the time period for it to respond to the Commission's Order of August 12, 1992. Clark stated that the ordered response date of August 26, 1992 would not allow its staff and certified public accountant sufficient time to properly reply to all questions as the reason the extension should be granted.

The Commission finds that Clark's request for an additional 5 working days to respond to the August 12, 1992 Order is reasonable and should be granted. However, allowing these additional days will require a modification of the procedural schedule previously established.

IT IS THEREFORE ORDERED that:

1. Clark's motion to extend its response date for the August 12, 1992 Order to September 2, 1992 is hereby granted.

2. The procedural schedule established in the Commission's Order of July 23, 1992 is hereby amended to allow Clark 5 additional business days to respond to the August 12, 1992 Order and to make other modifications necessitated by the additional response time granted.

3. The amended procedural schedule marked Appendix A, attached hereto and incorporated herein, shall be followed.

4. All other provisions of the Commission's Order of July 23, 1992 shall remain in full force and effect.
