O R D E R

IT IS ORDERED that Central Kentucky Cellular Telephone Company ("Central Kentucky Cellular") shall file the original and 10 copies of the following information with the Commission with a copy to all parties of record within 10 days from the date of this Order. If the information cannot be provided by this date, Central Kentucky Cellular should submit a motion for an extension of time stating the reason a delay is necessary and include a date by which it will be furnished. Such motion will be considered by the Commission. Central Kentucky Cellular shall furnish with each response the name of the witness who will be available at any public hearing for responding to questions concerning each item of information requested.

1. Provide the location of telecommunications facilities operated by Central Kentucky Cellular including the names and addresses of adjacent property owners as requested in the attached letter from Mark and Kathleen Smith, intervenors in this proceeding. This information may be limited by Central Kentucky

Cellular to those facilities located within the Louisville Metropolitan Statistical Area.

2. Provide all studies and other information utilized by Central Kentucky Cellular to determine the possible ill effects of operating a cellular radio telecommunication service, including any hazards from prolonged exposure to microwave radiation and interference with telephones and other electronic equipment.

3. What alternative location sites did Central Kentucky Cellular have? Identify each and describe in detail why the alternative was not selected.

4. Provide verification that the microwave emissions of cellular telephone service are below Environmental Protection Agency standards.

5. Provide a summary of statements made by each representative of Central Kentucky Cellular at the October 23, 1992 meeting with intervenors and interested persons. Provide a copy of all information distributed to attendees and of charts or graphs used in the presentation. Also, provide information regarding any follow-up meetings that may have been scheduled.
