Contending that its response to the Commission's Order of November 24, 1992 adequately addresses all Commission concerns, Kenton County Water District No. 1 ("Kenton District") has requested the termination of this proceeding and cancellation of the scheduled hearing. 1. Kenton District's request for termination of this proceeding and cancellation of the scheduled hearing is denied.

An informal conference in this matter shall be held on January 20, 1993 at 10:30 a.m., Eastern Standard Time, in Conference Room 1 of the Commission's offices at 730 Schenkel Lane, Frankfort, Kentucky. The discussion at this conference shall be limited to the issues set forth in the Appendix to this Order. If

Kenton District wishes to discuss additional issues at the conference, it shall submit in writing a list of those issues to the Commission no later than January 10, 1993.

ORDER


On December 23, 1992, Salt River Rural Electric Cooperative Corporation ("Salt River") filed its notice of intent to file a petition. On December 28, 1992, Salt River requested permission to use an abbreviated form of newspaper notice of a rate change which includes a coupon which may be used to pay the total schedule of the rate changes.


After reviewing the petition and being otherwise sufficiently informed, the Commission finds that Salt River should be granted permission to use the abbreviated form of newspaper notice.


IT IS HEREBY ORDERED that Salt River is granted permission to use the abbreviated form of newspaper notice specified in 807 KAR 015.008 on page 8.


