O R D E R

Pursuant to 807 KAR 5:056, Section 1(11), IT IS HEREBY ORDERED
that:

1. A public hearing shall be held on February 18, 1993 at 9:00 a.m., Eastern Standard Time, at the Commission's offices in Frankfort, Kentucky, to examine the application of the fuel adjustment clause of Blue Grass Rural Electric Cooperative Corporation ("Blue Grass") from November 1, 1990 through October 31, 1992. If no interested party files with the Commission by February 16, 1993 written notice of its intent to attend this hearing, this public hearing shall be cancelled.

2. Blue Grass shall file with the Commission on or before December 18, 1992 an affidavit attesting to its compliance or noncompliance with the requirements of 807 KAR 5:056.


3. Blue Grass shall publish the following notice not less than 7 days nor more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas or in a trade publication or newsletter going to all customers:

A public hearing will be held on Thursday, February 18, 1993, at 9:00 a.m., Eastern Standard Time, at the offices of the Kentucky Public Service Commission, 730 Schenkel Lane, Frankfort, Kentucky, to examine the application of the fuel adjustment clause of Blue Grass Rural Electric Cooperative Corporation for the period November 1, 1990 to October 31, 1992. Individuals interested in attending this hearing shall notify the Public Service Commission in writing of their intent to attend no later than February 16, 1993. If no notices of intent to attend are received by that date, this hearing will be cancelled. Written notice of intent to attend this hearing should be sent to: Don Mills, Executive Director, Kentucky Public Service Commission, P.O. Box 615, Frankfort, Kentucky 40602.


4. Blue Grass shall, on or before December 18, 1992, file an original and 10 copies of the information requested in Appendix A, attached hereto and incorporated herein, with the Commission. Each copy shall be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Blue Grass shall furnish with each response the name of the witness who will be available at the public hearing to respond to questions concerning each area of information requested. Careful attention shall be given to copied material to ensure that it is legible.

APPENDIX A

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE
COMMISSION IN CASE NO. 92-497 DATED December 3, 1992.

1. Provide the following line loss information:
 - a. A schedule of the calculation of the 12-month average line loss by month for November 1990 through October 1992.
 - b. A discussion of the steps that have been taken to reduce line loss during these periods.
2. Provide a schedule showing the calculation of monthly over- or under-recovery of fuel costs from November 1, 1990 through October 31, 1992.
3. Provide a copy of Blue Grass' monthly revenue reports (monthly billing summaries) showing the total revenue collected, including adjustments, under the fuel adjustment clause reported in Blue Grass' monthly filings required by the Commission from November 1, 1990 through October 31, 1992.
4. Provide a schedule showing the calculation of the increase or decrease in Blue Grass' base fuel cost per KWH as proposed by its wholesale electric supplier adjusted for Blue Grass' 12-month average line loss for November 1990 through October 1992.
5. Provide a schedule of the present and proposed rates which Blue Grass seeks to change pursuant to 807 KAR 5:056 as calculated in Item 4 above, shown in comparative form.
6. Provide a statement showing by cross-outs and italicized inserts all proposed changes in rates. A copy of the current tariff may be used.
