O R D E R

On May 23, 1991, the Commission issued its Order in Case No. 90-342 approving certain adjustments in rates and providing under certain conditions for the further adjustment of such rates on a quarterly basis in accordance with the provisions of the Gas Cost Adjustment ("GCA") Clause set forth therein.

On June 29, 1993, Delta Natural Gas Company, Inc. ("Delta") filed its quarterly GCA, which is to become effective August 1, 1993 and is to remain in effect until November 1, 1993.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta's notice of June 29, 1993 set out certain revisions in rates which Delta proposed to place into effect, said rates being designed to pass on to its customers the wholesale increase in gas costs from its suppliers. Delta's expected gas cost for the quarter beginning August 1, 1993 is \$2.9464 per Mcf, an increase of 16.65 cents per Mcf excluding take-or-pay billings.

Delta's notice set out a take-or-pay recovery component of .43 cent per Mcf, which increased .56 cent per Mcf from its last GCA filing. Delta should be prepared to support the amount of its

its take-or-pay actual adjustments at the time of its GCA field reviews.

2. Delta's notice contained a refund adjustment of 7.6 cents per Mcf to return to its customers supplier refunds in the amount of \$30,527, including interest. Delta's total refund adjustment of 9.6 cents per Mcf is composed of the current quarter adjustment and a previous quarter adjustment.

3. Delta's notice set out a current quarter actual adjustment in the amount of (26.86) cents per Mcf to compensate for over-recovery of gas cost by the company through the operation of its gas cost recovery procedure during the months of February, March, and April 1993. The total actual adjustment of 14.27 cents per Mcf is designed to correct the current over-collection as well as under- and over-collections from three previous quarters.

4. Delta's notice set out a balance adjustment of 7.72 cents per Mcf, to replace the previous adjustment of (2.77) cents per Mcf. This balance adjustment compensates for under-collections which occurred as a result of previous gas cost, actual, refund, and balance adjustments.

5. The combined effect of the above adjustments is Delta's gas cost recovery rate ("GCR") in the amount of \$3.1610 per Mcf, which is an increase of 19.11 cents per Mcf from its last approved GCR. The increase is the result of the supplier increase combined with the changes in other adjustments.

6. Delta's adjustment in rates, set out in the Appendix to this Order, pursuant to the GCA provisions approved by the

Commission in its Order in Case No. 90-342 dated May 23, 1991, is fair, just, and reasonable, in the public interest, and should be effective with final meter readings on and after August 1, 1993.

7. In its filing dated June 29, 1993, Delta requested confidentiality for Schedule VI, which contains business information required by the Commission pertaining to Delta's subsidiaries. Delta Resources, Inc. and Delgasco engage in activities that are unregulated and highly competitive. Competitors of these subsidiaries could use business information of these subsidiaries to place themselves in an advantageous position vis-a-vis the subsidiaries and Delta. Thus, disclosure of the information is likely to cause Delta and these subsidiaries competitive injury and should be protected.

IT IS THEREFORE ORDERED that:


1. The rates in the Appendix, attached hereto and incorporated herein, are fair, just, and reasonable and are approved effective with final meter readings on and after August 1, 1993.


2. Within 30 days of the date of this Order, Delta shall file with this Commission its revised tariffs setting out the rates authorized herein.


3. Schedule VI, which Delta has petitioned to be withheld from public disclosure, shall be held and retained by this Commission as confidential and shall not be open for public inspection.
