O R D E R

On January 29, 1993, Western Kentucky Gas Company, a division of Atmos Energy, Inc. ("Western") filed an application with the Commission wherein it proposed changes to its Gas Cost Adjustment Clause and proposed two new large volume sales tariffs LVS-1 and LVS-2 effective March 1, 1993. The application was rejected as deficient and Western cured that deficiency on March 31, 1993 proposing a new effective date of May 1, 1993. Upon application of KRS 278.190 the Commission suspended Western's filing up to and including September 30, 1993. Western, the Intervenors in this proceeding, and Commission Staff met at Western's request at an informal conference held May 21, 1993.

IT IS ORDERED that:

1. The procedural schedule set forth in the Appendix to this Order shall be followed by all parties.

2. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 11 copies to the Commission.


3. Western shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5). At the time publication is requested, Western shall forward a duplicate of the notice and request to the Commission.

4. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of compelling reasons.

5. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
