O R D E R


On September 28, 1993, the Commission issued an Order which prescribed new rates for Salt River Electric Cooperative Corporation. Upon further review, the Commission finds that these rates failed to reflect the impact of the fuel adjustment clause roll-in approved in Case No. 92-514.¹ It further finds that the rates set forth in Appendix A of this Order reflect this impact and will produce the revenues found reasonable in the Commission's Order of September 28, 1993.




