O R D E R

On January 4, 1993, West Shelby Water District ("West Shelby") filed an application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

1. West Shelby purchases water from three suppliers, Shelbyville Municipal Water ("Shelbyville"), North Shelby Water Company ("North Shelby"), and the Louisville Water Company ("Louisville").

2. Louisville increased its rate for water sold from \$1.29 to \$1.32 per 1,000 gallons effective January 1, 1993. The other two suppliers, Shelbyville and North Shelby, will not increase their rates at this time. West Shelby proposes to increase the water rates to its customers effective January 15, 1993.

3. During the 12 months ending November 30, 1992, West Shelby purchased 145,235,900 gallons of water and sold 130,119,300

gallons. These figures are representative of all three suppliers. West Shelby purchased 45,550,000 gallons from Louisville at a cost of \$60,112.02.

4. The increase in West Shelby's purchased water cost is \$1,280.94, resulting in a purchased water adjustment of 1 cent per 1,000 gallons.

5. The purchased water adjustment of 1 cent per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

6. West Shelby's proposed tariffs are correct and should be approved.

IT IS THEREFORE ORDERED that:


1. The purchased water adjustment of 1 cent per 1,000 gallons and the rates in Appendix A are hereby approved for services rendered on and after January 15, 1993.

2. West Shelby's proposed tariffs are approved as filed for services rendered on or after January 15, 1993.


3. Within 30 days of the date of this Order, West Shelby shall file a copy of the notice to its customers and verification that such notice has been given.
