O R D E R

On April 14, 1993, Mud Creek Water District ("Mud Creek") filed an application with the Commission seeking authority to increase its 5/8 x 3/4 meter inch Tap-On Fee from \$250 to \$425; its Turn-On Charge from \$15 to \$25; its Special Meter Reading Charge from \$5 to \$25; its Meter Test Charge from \$7.50 to \$25 plus actual test cost; and its Meter Reset Charge from \$15 to \$25. Mud Creek also proposed to establish a Termination or Field Collection Charge of \$25; a Returned Check Charge of \$20 and a Late Payment Penalty of 10 percent.

Mud Creek's initial application included cost justification of the 5/8 x 3/4 inch Meter Tap-On Fee for expenses totaling \$753.20. On May 7, 1993, the utility filed a revised cost justification for this fee for expenses totaling \$440.88.

The Commission finds that Mud Creek has provided evidence of the individual expenses incurred to provide the services associated with the proposed charges, including the revised cost justification for 5/8 x 3/4 inch Meter Tap-On Fees. After reviewing the evidence and being sufficiently advised, the Commission finds that the proposed charges are equal to the expenses incurred to provide the

associated services. Based on these expenses, the Commission finds that the charges set forth in the Appendix to this Order are fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. The charges in the Appendix to this Order, which is attached hereto and incorporated herein, are approved for services rendered on and after the date of this Order.


2. Within 30 days of the date of this Order, Mud Creek shall file its revised tariff sheets setting out the charges approved herein.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE  
COMMISSION IN CASE NO. 93-110 DATED June 1, 1993.

The following rates and charges are prescribed for the customers in the area served by Mud Creek Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.

### Non-Recurring Charges

5/8 x 3/4 Inch Meter Tap-On Fee	\$440
Turn-On Charge	\$ 25
Reconnection Charge	\$ 15
Termination or Field Collection Charge	\$ 25
Special Meter Reading Charge	\$ 25
Meter Test Charge	\$ 25 (Plus Actual Test Cost)
Returned Check Charge	\$ 20
Meter Reset Charge	\$ 25
Late Payment Penalty	10 percent
