O R D E R

On June 29, 1993, Hershel I. McKinley filed a letter, attached hereto as Appendix A, which the Commission will treat as a motion, requesting full intervention and responses to an information request. Mr. McKinley owns property within 500 feet of the cellular tower proposed to be constructed by Lexington MSA Limited Partnership ("Lexington MSALP"). The Commission, having considered the motion and being otherwise sufficiently advised, hereby finds that Mr. McKinley has a special interest which is not otherwise adequately represented, that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings.

IT IS THEREFORE ORDERED that:

1. The motion of Mr. McKinley to intervene be and it hereby is granted.
2. Mr. McKinley shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with

filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.


3. Should Mr. McKinley file documents of any kind with the Commission in the course of these proceedings, he shall also serve a copy of said documents on all other parties of record.


4. Lexington MSALP shall respond to Mr. McKinley's request for information and file copies of its response with the Commission within 14 days of the date of this Order.

Thank you for your information and the order of the Kentucky Public Service Commission of June 10, 1993 requiring BellSouth Mobility to respond to my objections to the construction of a 293 foot tall self-supporting cellular telecommunications tower and antenna at 211 Forest Ave. in Danville, Kentucky.

The cordial letter of explanation from Ms. Susan Israel of BellSouth Cellular Corp. does not sway me from my original objections.

Therefore, I request full intervention and a hearing in this case. I further request that the Kentucky Public Service Commission set a procedural schedule in the matter.

I also make a request for information concerning this case. I wish to know if there have been any other objections filed, copies of any documents from BellSouth Mobility showing alternate tower locations within the service area, copies of studies and reports in the decision to utilize the present proposed location, and the names of the principals in Lexington MSA Limited Partnership.
