O R D E R

IT IS ORDERED that Kentucky Fiberlink, Co. ("Kentucky Fiberlink") shall file the original and ten copies of the following information with the Commission. The information requested shall be placed in a bound volume with each item tabbed.

The information requested herein is due no later than 30 days from the date of this Order. If the information cannot be provided by this date, Kentucky Fiberlink shall submit a motion for an extension of time stating the reason a delay is necessary and include a date by which the information can be furnished. Such motion will be considered by the Commission.

1. Kentucky Fiberlink proposes to provide private line service throughout the Commonwealth of Kentucky. On page 5 of its application, Kentucky Fiberlink informs the Commission of its ability to provide switched telecommunications services. If Kentucky Fiberlink plans to provide private line service, why is this relevant to this case?

2. Will Kentucky Fiberlink comply with Administrative Case 323?<sup>1</sup>

3. After the private line service is ordered, is there a period in which it may be canceled without accruing charges to the subscriber?

4. Refer to Original Sheet 45, Heading 5.7 I, Other Changes to an Order. Specify where the Design Change Charge is located in your proposed tariff, if applicable.

5. Explain in your proposed tariff how fractional charges and credits are calculated. Refer to AT&T's Private Services Tariff G.

6. Refer to Original Sheet 51, Heading 6.1.G1 of your proposed tariff. If the monthly charge is mileage sensitive, include all bands and rates thereof.

7. Refer to Original Sheet 84, Heading 9.4 of your proposed tariff. Does Kentucky Fiberlink have a service assurance warranty? If so, state the length of time it operates and whether there is a provision for credit for interruption.

8. Refer to Original Sheet 88, Heading 9.8.B.2, 3 and 4. These sections are in conflict with Original Sheet 86, 9.8.A. Clarify the Disconnect with Liability section.

9. Refer to Original Sheet No. 111, Heading 12.7A of your proposed tariff. Is the correct installation charge \$223 instead of \$233?

10. Explain why the cancellation charge includes 100 percent of local channel charge in Heading 11.7.

11. Refer to Original Sheet 31, Heading 5.5B fourth paragraph. Explain why a termination charge or maximum termination liability should be included in a deposit.

12. Specify the Kentucky counties Kentucky Fiberlink proposes to serve.

13. State a timetable in which Kentucky Fiberlink plans to provide private line telecommunication services throughout the Commonwealth of Kentucky.

14. Is Kentucky Fiberlink willing to comply with all the provisions contained in Administrative Case No. 338?<sup>2</sup>

15. State whether all the specific rates and volume discounts for services provided are included in the proposed tariff.

16. Are any of your planned points-of-presence ("POPs") connected with any other long-distance carrier? Do you plan to offer special access in the future?

17. Refer to Original Sheet 41, Heading 5.7D Cancellation of an Order. Explain why these dates are not on the cancellation schedule:

a. Application Date: The date on which the customer provides a firm commitment and sufficient information to Kentucky Fiberlink to proceed with issuance of a firm order for service.


b. Scheduled Issue Date: The date on which the service order is entered into Kentucky Fiberlink's service order distribution system.

c. Layout Report Date: The date on which the Design Layout Report or access interface information is received by Kentucky Fiberlink from the LEC.

d. Records Issue Date: The date on which all circuit design and assignment information is sent to the central office installation force.
