O R D E R

On September 30, 1991 in Case No. 90-402, the Commission approved certain adjusted rates for Martin Gas, Inc. ("Martin") and provided for their further adjustment when the wholesale cost of gas changes or a refund is received.

On November 28, 1994, Martin filed to pass on its decreased wholesale gas cost from Columbia Gas of Kentucky, Inc. ("Columbia"), effective December 1, 1994.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Martin's notice proposed revised rates designed to pass on to its customers Columbia's Intrastate Utility Service ("IUS") rate of \$4.0276 per Mcf.

2. The Commission approved the IUS rate of \$4.0276 per Mcf effective December 1, 1994.¹

3. The rate adjustment in the Appendix to this Order is fair, just, and reasonable, in the public interest, and should be approved effective December 1, 1994.

4. Within 30 days of the date of this Order, Martin should file the amount of any over-collections resulting from the delay in placing these rates into effect, along with a plan to refund such over-collections to its customers.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are fair, just, and reasonable and are approved effective for gas supplied on and after December 1, 1994.


2. Within 30 days of the date of this Order, Martin shall file with this Commission its revised tariffs setting out the rates authorized herein.
