## ORDER

Pursuant to 807 KAR 5:056, Section 1(11), IT IS HEREBY ORDERED that:

- 1. A public hearing shall be held on August 30, 1994 at 9:00 a.m., Eastern Daylight Time, at the Commission's offices in Frankfort, Kentucky, to examine the application of the fuel adjustment clause of Meade County Rural Electric Cooperative Corporation ("Meade County") from November 1, 1993 through April 30, 1994.
