## ORDER

On February 3, 1994, White Hall Water District ("White Hall") filed its application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

- 1. White Hall purchases water from Richmond Water, Gas and Sewerage Works ("Richmond").
- 2. Effective January 1, 1994, Richmond will increase its rates for wholesale water from \$1.50 per cubic feet to \$1.54 per cubic feet. Based on an average monthly usage of 5,000 gallons, monthly rates to White Hall's customers will increase from \$26.92 to \$27.19, an increase of 1 percent.
- 3. White Hall proposed to increase the rates to its customers effective April 1, 1994.
- 4. During the 12 months ending November 30, 1993, White Hall purchased 18,607,800 cubic feet of water and sold 16,762,248 cubic feet.

- 5. White Hall's calculations are correct and show an increase in purchased water cost of \$7,443, resulting in a purchased water adjustment of 4 cents per 100 cubic feet.
- 6. The purchased water adjustment of 4 cents per 100 cubic feet and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of 4 cents per 100 cubic feet and the rates in Appendix A are approved for services rendered on and after April 1, 1994.
  - 2. White Hall's proposed tariff is approved.
- 3. Within 30 days of the date of this Order, White Hall shall file verification that the notice to its customers has been given.
