O R D E R

IT IS ORDERED that South Williamson Lodging, Inc. ("South Williamson") and Little Pearl Trucking Company, Inc. ("Little Pearl") shall file the original and six copies of the following information with the Commission with a copy to all parties of record no later than January 4, 1995. Include with each response the name of the witness who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure that it is legible.

Little Pearl shall respond to the following questions:

1. When was the water line constructed?
2. What is the size, length, and type of pipe installed?
3. Describe in detail any facilities installed by Little Pearl in addition to those listed in Item 2, above, such as pumps or storage tanks.
4. What was the total construction cost and how was the cost financed?
5. Provide the name and address of each residential customer served by Little Pearl's water line.

6. Provide the name, address, and nature of business of each nonresidential customer served by Little Pearl's water line.

7. Provide a schedule showing the amount of charges assessed each customer identified in Items 5 and 6, above, for each month for the most recent 12-month period.

8. Provide a detailed description in words and figures of the derivation of the charges assessed each customer for the water line.

9. Provide copies of invoices and receipts for all operation and maintenance expenses incurred since completion of the water line.

10. Why did Little Pearl not recover the cost of the water line through the sale of the properties served by such line?

11. Is each customer's water usage individually metered? If yes, describe the location of each customer's water meter and indicate who owns each meter.

12. Does Little Pearl assess each customer a charge for the water consumed? If yes, describe in words and figures the derivation of the water charge and provide copies of each monthly bill rendered in the most recent 12-month period. If no, who bills the customers for the water consumed?

13. Does Little Pearl own the property where the water line is located? If not, who owns the property?

14. Are there easements for the property where the water line is located? If yes, who owns such easements?

15. Did Little Pearl construct a sewer line to provide service to South Williamson or any other customer? If yes, provide the same information requested in Items 1 through 14, above, for the sewer line.

16. What are the rates charged by the City of Williamson, West Virginia, for sewer services provided to Little Pearl?

South Williamson shall respond to the following questions:


1. Provide copies of any water bills received from Mountain Water District.

2. Provide copies of any sewer bills received from the City of Williamson.

3. Provide copies of bills received from Little Pearl for water or sewer service.
