ORDER

On April 11, 1994, Bullock Pen Water District ("Bullock Pen") filed an application to request authority to increase its 5/8 x 3/4 inch meter connection fee from \$390 to \$475, to increase its 1 inch meter connection fee from \$585 to \$640, and to allow a \$275 refund to mobile home park owners and subdivision developers who install a meter crock and meter lid suitable for meter installation upon payment of the \$475 connection fee. Bullock Pen also requested an amendment to its tariff regarding the installation of water lines within single-family development subdivisions, the billing and installation of water meters for multi-family apartment buildings, and the installation of water meters for mobile home units.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

- 1. Bullock Pen's calculations of costs support the proposed charges and refund.
- 2. The charges and refund set forth in the Appendix to this Order, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

- 3. The proposed tariff filed April 11, 1994 and revisions filed July 15, 1994 should be approved.
- 4. Notification of these rate increases was published and Affidavits of Notification were filed on August 29, 1994.

IT IS THEREFORE ORDERED that:

- 1. The charges and refund in the Appendix are approved for services rendered on and after the date of this Order.
- 2. Within 30 days of the date of this Order, Bullock Pen shall file its revised tariff setting out the charges, refund and amendments approved herein.
