O R D E R

IT IS ORDERED that Kentucky Utilities Company ("KU") shall file the original and 12 copies of the following information with the Commission, with a copy to all parties of record, within 20 days of the date of this Order. KU shall furnish with each response the name of the witness who will be available at the public hearing to respond to questions concerning each item of information requested.

1. Provide the mailing address and telephone number for the following persons:

- a. James David Stratton
- b. William Mackay Bailey

2. For each person listed in Question 1,

- a. State the length of his employment with KU.
- b. List all positions with KU which he has held, his length of service at each position, and each position's duties.
- c. List all other positions which he has held which involved the construction or maintenance of electric distribution lines.

d. Describe his education background (including any technical or vocational education).

e. (1) State whether he had violated any KU work rule prior to September 13, 1993.

(2) If yes, state the date of each violation, its nature, and any disciplinary action which KU took against him.

3. a. State whether KU has taken any disciplinary action(s) against any of the persons listed in Question 1 for the September 13, 1993 incident.

b. If yes, describe the nature of that action.

4. Provide any reports on the September 13, 1993 incident which were prepared by any local, state, or federal governmental agency or by KU for such agencies and which have not previously been submitted to the Commission.

5. a. Describe James David Stratton's injuries and the medical treatment which he received for them.

b. State the number of work days which Stratton lost as a result of the incident.

c. State the date when Martin returned to work.

6. Describe KU's actions since the September 13, 1993 incident to prevent similar incidents.

7. Identify the witnesses KU intends to call at the scheduled hearing and summarize the expected testimony of each witness.

8. a. State whether any civil actions arising out of the September 13, 1993 incident, including claims under the workers' compensation laws, have been brought against KU.

b. If yes, for each action.

(1) Identify the complainant.

(2) Provide a copy of the complaint.

(3) Provide a copy of any answer or response made by KU.

(4) What is its current status?

9. a. Provide a copy of KU's current Safety Manual.

b. Identify any changes which were made in this manual since the September 13, 1993 incident.

10. a. Explain how KU ensures that its foremen and supervisors enforce KU's work and safety rules.

b. If these procedures are published, provide a written copy.

c. State the date when each procedure was established.

11. Describe what Bailey was doing while Stratton was working on the 7200-volt line.

12. State where Bailey was located when Stratton was working on the line.

13. State the distance between Stratton and Bailey when the incident occurred.

14. a. State whether any other KU employees were present when Stratton was injured.

b. Identify these employees, state their position with KU, and describe what they were doing at the time of the incident.

15. Describe the weather conditions at the time of the incident.

16. List and describe the disciplinary measures which KU may take against employees who have violated its work rules.

17. a. Identify each incident during the period from January 1, 1993 to April 30, 1994 in which KU cited an employee for violating a safety rule.

b. For each incident listed above, describe the disciplinary action, if any, which KU took.
