ORDER

On May 25, 1994, Northeast Woodford Water District ("Northeast") filed its application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278,015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

 Northeast purchases water from the City of Versailles ("Versailles").

2. Effective May 1, 1994, Versailles will increase its rate for wholesale water from \$1.47 per 1,000 gallons to \$1.52 per 1,000 gallons.

3. KAR 5:068 requires that within twenty (20) days after any such purchased water rate adjustment, the district shall file with the Commission its revised tariff sheets setting forth the adjusted rates. Because the increase from Versailles is effective May 1, 1994 and Northeast did not file its proposed adjustment in rates with the Commission until May 25, 1994, the effective date of the Northeast increase shall be May 5, 1994. 4. During the 12 months ending Narch 31, 1994, Northeast purchased 112,516,000 gallons of water and sold 102,542,000 gallons.

5. Northeast's calculations are correct and show an increase in purchased water cost of \$5,626, resulting in a purchased water adjustment of 6 cents per 1,000 gallons. Based on an average monthly usage of 5,000 gallons, monthly bills to Northeast customers will increase 30 cents from \$15.05 to \$15.35, an increase of 2 percent.

6. The purchased water adjustment of 6 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of 6 cents per 1,000 gallons and the rates in Appendix A are approved for services rendered on and after May 5, 1994.

2. Northeast's proposed tariff is approved.

3. Within 30 days of the date of this Order, Northeast shall file verification that the notice to its customers has been given.
