O R D E R

On August 2, 1994, East Daviess County Water Association, Inc. ("East Daviess") filed its application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure. KRS 278.012; 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

- 1. East Daviess purchases water from two suppliers,
 Owensboro Municipal Utilities ("OMU") and Southeast Daviess County
 Water District ("Southeast Daviess").
- 2. Effective June 1, 1994, OMU increased its rates for wholesale water from \$1.05 per 1,000 gallons to \$1.093 per 1,000 gallons.
- 3. Effective July 1, 1994, Southcast Daviess increased its rates for wholesale water from \$1.27 per 1,000 gallons to \$1.32 per 1,000 gallons.
- 4. East Daviess proposed to increase the rates to its customers effective August 1, 1994.

- 5. During the 12 months ending June 30, 1994, East Daviess purchased 232,251,100 gallons of water and sold 200,008,842 gallons.
- 6. East Daviess' calculations are correct and show an increase in purchased water cost of \$10,379.04, resulting in a purchased water adjustment of 5 cents per 1,000 gallons. Based on an average monthly usage of 5,000 gallons, monthly bills to East Daviess' customers will increase 25 cents from \$17.40 to \$17.65, an increase of 1 percent.
- 7. The purchased water adjustment of 5 cents per 1,000 gallons and the rates in Appendix A are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of 5 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are approved for services rendered on and after August 1, 1994.
 - 2. East Daviess' proposed tariff is approved.
- 3. Within 30 days of the date of this Order, East Daviess shall file verification that the notice to its customers has been given.
