Dear Sire.

I received by mail and am writing in response to your letter from Sam G. McNamara, Attorney at Law, regarding Public Notice, Case #94-285, construction of a 200 foot freestanding tower.

I am against the construction of this tower at its proposed location and am exercising my rights as a property owner to intervene in this matter.

There are several homes at the site of the proposed construction. Mine is one of those. This proposed tower will be located within approximately 75-100 yards from my front door. Construction of this tower will no doubt decrease the value of my home and property as well as that of my neighbor's. My family and I have owned this property since the early 1950's. One tower was erected on the Cornn property several years ago by one of the TV stations. I don't recall that any of the adjacent property owners feelings were considered at that time. Initially that tower caused no problems other than its ugly appearance. But as they continued to add antennas and equipment, some of these additions caused considerable electronic interference. Many of my television channels pick up unwanted transmissions from the tower. I receive a telephone beeper service "BEEP ALERT OF LEXINGTON" on both my television and Weather Alert. Efforts to correct this with the company have failed. So what they are telling me is that once the antenna system is in there is not a lot I can do about it. Well I don't want or need any more of this.

There is property available for this tower construction north of here on property as high as this which has no housing, on a ridge which already has a tower and I feel sure it would be welcomed by the property owner.

I only recently replaced my home at 225 Clifty Drive with a new home built and occupied in July 1993. I didn't know at the time I built this home that things like this tower nearly in my front yard would be something I'd have to look at in the future.

It is requested that the construction and erection of this tower be denied.
