ORDER

On August 18, 1994, North Mercer Water District ("North Mercer") filed an application to adjust its rates pursuant to the purchased water adjustment procedure, KRS 278:015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

- 1. North Mercer purchases water from one supplier, the City of Harrodsburg Water Department ("Harrodsburg").
- 2. Effective July 1, 1994, Harrodsburg increased its rates for wholesale water from \$1.11 per 1,000 gallons to \$1.154 per 1,000 gallons.
- 3. North Mercer proposes to increase the rates to its customers effective September 20, 1994.
- 4. During the 12 months ending July 31, 1994, North Mercer purchased 179,988,512 gallons of water and sold 141,375,780 gallons.
- 5. North Mercer's calculations are correct and show an increase in purchased water cost of \$7,920, but due to an incorrect rounding procedure, the factor is 6 cents, not 5 cents per 1,000 gallons as stated in the application. Based on an average monthly usage of 5,000 gallons, monthly bills to North Mercer's customers

will increase 30 cents, from \$23.90 to \$24.20, an increase of 1 percent.

6. The purchased water adjustment of 6 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by North Mercer are hereby denied.
- 2. The purchased water adjustment of 6 cents per 1,000 gallons and the rates in Appendix A are hereby approved for services rendered on and after September 20, 1994.
- 3. Within 30 days of the date of this Order, North Mercer shall file revised tariff sheets setting out the rates approved herein.
- 4. Within 20 days of the date of this Order, North Mercer shall file verification that the notice to its customers has been given.
