O R D E R

Louisville Gas and Electric Company ("LG&E") has applied, pursuant to KRS 278.183, for approval of its environmental compliance plan and rate surcharge to recover its costs of environmental compliance. LG&E proposes to make the surcharge effective on May 1, 1995.

After reviewing the application and being otherwise sufficiently advised, the Commission finds that further proceedings are necessary to determine the reasonableness and cost-effectiveness of the proposed environmental compliance plan and rate surcharge.

IT IS THEREFORE ORDERED that:

1. LG&E shall not assess its proposed environmental surcharge prior to the proposed effective date of May 1, 1995.
2. The procedural schedule set forth in Appendix A to this Order shall be followed.
3. All requests for information and responses thereto shall be appropriately indexed. All responses shall include the name of

the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 10 copies to the Commission.


4. LG&E shall give notice of the hearing in accordance with 807 KAR 5:011, Section 8(5). At the time publication is requested, LG&E shall forward a duplicate of the notice and request to the Commission.

5. Motions for extensions of time with respect to the schedule herein shall be made in writing and shall be granted only upon a showing of good cause.

6. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
