ORDER TO SATISFY OR ANSWER



The Complaint of B & H Gas Company, Inc. respectfully

shows:

(A) That B & H Gas Company, Inc. is a natural gas supplier in Floyd County, Kentucky.

(B) That Columbia Gas of Kentucky, Inc. is a natural gas supplier to residents and commercial units in Floyd County, Kentucky.

(C) That B & H Gas Company, Inc. is a natural gas supplier to residents and commercial units in the area of the southern part of Floyd County, Kentucky - the Tram, Ivel, Stanville, Betsy Layne and Mare Creek area. B & H Gas Company, Inc. has approximately Three Hundred and Four (304) residential customers and Twenty One (21) commercial customers; that Columbia Gas of Kentucky, Inc. has taken two customers from B & H Gas Company, Inc. whose names are Judy Hall, Betsy Layne, Floyd County, Kentucky and Jimmy and Vickie Rose, Betsy Layne, Floyd County, Kentucky; that if Columbia Gas of Kentucky, Inc. is allowed to take B & H Gas Company, Inc.'s customers, an economic hardship and burden shall be created such that B & H Gas Company,

Inc. cannot meet its financial obligations and serve its customers; and that as a result of the creation of the referenced economic hardship and burden upon B & H Gas Company, Inc., the public interest would not be best served.

WHEREFORE, Complainant ask that the Public Service Commission order Columbia Gas of Kentucky, Inc. to cease taking B & H Gas Company, Inc.'s customers and further order Columbia Gas of Kentucky, Inc. to compensate B & H Gas Company, Inc. for the two (2) customers it took from B & H Gas Company, Inc. or order Columbia Gas of Kentucky, Inc. to terminate its service to the said two (2) customers.
