O R D E R

On November 11, 1994, West Shelby Water District ("West Shelby") filed an application with the Public Service Commission ("Commission") for the purpose of adjusting its rates pursuant to the purchased water adjustment procedure, KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

1. West Shelby purchases water from three suppliers, the Louisville Water Company ("Louisville"), Shelbyville Municipal Water ("Shelbyville"), and North Shelby Water Company ("North Shelby").

2. Louisville increased its rate for water sold from \$1.32 per 1,000 gallons to \$1.35 per 1,000 gallons effective January 1, 1994. Shelbyville increased its rate for water sold from \$1.00 per 1,000 gallons to \$1.15 per 1,000 gallons effective August 19, 1994. North Shelby increased its rates for water sold 6 cents per 1,000 gallons effective April 7, 1994.

3. During the 12 months ending August 31, 1994, West Shelby purchased 181,750,100 gallons of water and sold 167,587,400 gallons

at a cost of \$201,936. These figures include water from all three suppliers.

4. The increase in West Shelby's purchased water cost is \$20,525.40, resulting in a purchased water adjustment of 12 cents per 1,000 gallons.

5. West Shelby proposed to increase its water rates accordingly, effective December 30, 1994.

6. The new rates proposed in West Shelby's initial application were incorrect. West Shelby filed corrected tariff sheets on December 5, 1994.

7. The purchased water adjustment of 12 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

8. West Shelby's amended proposed tariffs are correct and should be approved.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of 12 cents per 1,000 gallons and the rates in Appendix A are hereby approved for services rendered on and after December 20, 1994.

2. West Shelby's amended proposed tariffs are approved for services rendered on and after December 20, 1994.

3. Within 30 days of the date of this Order, West Shelby shall file verification that notice of this rate adjustment has been given to its customers.
