O R D E R

On April 28, 1995, Berea College Electric Utility ("Berea") tendered for filing an application for an adjustment of rates to become effective May 31, 1995. Upon review of the application, the Commission noted certain filing deficiencies. The deficiencies were cured and the application accepted for filing on May 19, 1995. Pursuant to KRS 278.180(1), no utility may change any rate except upon 30 days notice to the Commission. Since the application was filed on May 19, 1995, the proposed rates may become effective on June 18, 1995.

The Commission finds that, pursuant to KRS 278.190, further proceedings are necessary in order to determine the reasonableness of the proposed rates and that such proceedings cannot be completed prior to the proposed effective date.

IT IS THEREFORE ORDERED that:

1. The proposed rates be and hereby are suspended for 5 months from June 18, 1995 up to and including November 17, 1995.
2. The procedural schedule listed in Appendix A, which is attached hereto and incorporated herein, shall be followed.
3. All requests for information and responses thereto shall be appropriately tabbed and indexed. All responses shall include

the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 10 copies to the Commission.

4. Berea shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5). At the time publication is requested, the applicant shall forward a duplicate of the notice and request to the Commission.

5. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of compelling reasons.

6. Nothing contained herein shall prevent the Commission from entering a final decision in this case prior to the termination of the suspension period.
