ORDER

On June 6, 1995, Steven J. Olshewsky filed a formal complaint naming Columbia Gas of Kentucky, Inc. ("Columbia") as defendant. Columbia filed its answer and memorandum in support of its answer on September 12, 1995. The Commission finds that the procedural schedule set forth below should be followed by the parties to this proceeding. Each party should also file with the Commission an original and 10 copies of the information requested in the Appendix and serve a copy on all parties of record within 15 days from the date of this Order. Furnish with each response the name of the witness who will be available to respond to questions concerning each of the items requested.

IT IS HEREBY ORDERED that:

1. Each party may, on or before November 3, 1995 serve upon any other party a request for production of documents and written interrogatories to be answered by the party served within 14 days of service.

2. Each party may, on or before December 1, 1995 serve upon the other party a supplemental request for production of documents

and supplemental written interrogatories to be answered by the

party served within 10 days of service.

3. Each party shall, on or before December 15, 1995 serve

upon the other parties a written summary of the testimony of the

witnesses who are expected to be called at the formal hearing,

copies of all exhibits which will be used at the hearing regardless

of whether they are to be introduced, and all preliminary motions

and objections, except objections to exhibits. All exhibits shall

be appropriately marked.

4. Copies of all documents served upon any party shall be

served upon all other parties and simultaneously filed with the

Commission.

5. A formal hearing in this matter shall be held on December

19, 1995, at 10:00 a.m., Eastern Standard Time, in Hearing Room 1

of the Commission's offices at 730 Schenkel Lane, Frankfort,

Kentucky.

APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 95-376 DATED OCTOBER 13, 1995
OUESTIONS FOR STEVEN J. OLSHEWSKY:

- 1. List all gas appliances used at 209 University Avenue, Lexington, Kentucky.
 - 2. Provide the rated capacity of each gas heating appliance.
- 3. Provide copies of all written correspondence including termination notices received from Columbia Gas between January 12, 1995 and April 27, 1995 for the residence.
- 4. When and in what manner did you request the 209 University Avenue account be placed in your name?
- 5. Provide any documentation available which shows a final meter reading of 1,223.5 on or about February 15 18, 1995.
- 6. What was the date of the original authorization of service?
- 7. What was the meter reading at the time of the original authorization of service?
- 8. Provide a computation of the alleged overcharges by Columbia for the 209 University Avenue account including any disconnect or reconnect fees paid.
- 9. Provide a computation of the alleged expenses incurred due to termination of gas service.

QUESTIONS FOR COLUMBIA:

- 10. Provide a copy of Mr. Olshewsky's request to transfer the 209 University Avenue account into his name.
- 11. Provide a copy of the disconnect request from the tenant, Christopher A. Sininger.

- 12. Provide a summary, including dates and copies of any relevant correspondence, relating to the termination of service at 209 University Avenue.
 - 13. Provide a copy of Columbia's termination policy.
- 14. Provide all billing records showing any account activity between January 1, 1995 and April 27, 1995 for the 209 University Avenue account.
- 15. Provide all documents which show the final meter reading when Mr. Sininger requested termination of gas service on January 12, 1995.
- 16. When was the account transferred into Mr. Olshewsky's name?
- 17. Provide all documents which show the initial meter reading at the time the service was transferred into Mr. Olshewsky's name.
- 18. Provide all documents and computations supporting the allegation that Mr. Olshewsky currently owes \$179.33 for service to the 209 University Avenue address. Separately state the amount of any termination or reconnect fees included.
- 19. Is the meter used to serve Mr. Sininger still located at 209 University Avenue?
- a. If not, provide details of its removal including the date of removal and the meter registration number.
 - b. If yes, has the meter been relocated? Explain.
- 20. Provide all meter test records for any meter used at 209 University Avenue between January 1, 1981 and April 27, 1995.

21. Provide copies of any budget payment plans for Mr. Sininger and Mr. Olshewsky for the 209 University Avenue account.
